As of December 31, 2018, the Reporting Persons Conestoga Capital Advisors indirectly beneficially owned 482,226 shares while the Conestoga Small Cap Fund owned 298,675 of the 482,226 of the Issuer's Common Stock indirectly beneficially owned by Conestoga Capital Advisors. Such shares of the Issuer's Common Stock were directly beneficially owned by the Accounts. The Conestoga Small Cap Fund beneficially owned more than 5.0% of the Issuer's issued and outstanding Common Stock.

As of December 31, 2018, the Reporting Persons indirectly beneficially owned 9.95% and 6.16% of the Issuer's issued and outstanding Common Stock (based on 4,844,010 shares of the Issuer's Common Stock outstanding as of October 12, 2018 as reported by the Issuer in its Quarterly Report on Form 10-Q filed with the Securities and Exchange Commission on October 15, 2018).
