Mr. Erickson may be deemed to possess beneficial ownership of 6,000 shares of Common Stock held by his wife and (ii) 26,000 shares of Common Stock held by his child; however, he disclaims beneficial ownership of these securities. As a result of Mr. Erickson's service on the Board of Directors of Holiday Stationstores, Inc.
