On April 4, 2007, Monsanto Company issued a press release announcing its second quarter 2007 financial and operating results for the period ended Feb. 28, 2007. This press release is furnished as Exhibit 99 hereto and incorporated herein by reference.

Our ongoing EPS financial measure excludes certain after-tax items that we do not consider part of ongoing operations, which are identified as such in the reconciliation. We believe that our ongoing EPS financial measure presented with these adjustments best reflects our ongoing performance and business operations during the periods presented and is more useful to investors for comparative purposes. In addition, management uses the ongoing EPS financial measure as a guide in its budgeting and long-range planning processes, and as a guide in determining incentive compensation. The presentation of EPS on an ongoing basis is intended to supplement investors understanding of our operating performance. This non-GAAP financial measure may not be comparable to similar measures used by other companies.
