- (2) Beneficial ownership of shares held in Voting Trust. Reporting person disclaims ownership of 188,622.5 (including 37350.5 shares acquired pursuant to a dividend reinvestment plan) owned by wife. Includes 6291 shares acquired pursuant to a dividend reinvestment plan.
- (3) Voluntary reporting of shares acquired in 2006 in the TDS 401K. The information is based on a plan statement dated 12/31/06. The number of shares fluctuates and is attributable to the price of the shares on 12/31/06.
- (4) Reporting person has deferred 1998, 1999, 2000, 2001, 2002, 2003 and 2004 bonuses pursuant to the 1998 Long term incentive plan. The deferred bonuses total 22,623.4 special common shares. The employer matches total 6560.8 and dividend reinvestment has accumulated to 1016.6 special common shares. The employer match vests ratably at 33%, 33% and 34% per year over a 3 year period. Some employer matches are fully vested while some matches are not fully vested.
- (5) Granted under the TDS 1998 Long term incentive plan. The option is exercisable with respect to 13200 common shares on 12/15/98, 12/15/99 and 12/15/00 for a total of 39,600 common shares.

The tandem option provides that upon exercise, the optionee purchases the number common shares originally subject to the option plus an equal number of special common.
