#### Concession for the Construction and Operation of Santa Isabel Power Plant

☐ Companhia Vale do Rio Doce (CVRD) informs that the Santa Isabel Generation Consortium (GESAI), which CVRD holds a 43.85% stake, asked ANEEL, the Brazilian regulatory agency for the electrical energy industry, to give back the concession contract for the construction and operation of Santa Isabel hydroelectric power plant, located at the states of Pará and Tocantins, Brazil.

GESAI asked for the devolution due to the refusal of IBAMA, the Brazilian environmental protection agency, to award the project the required environmental license.

This process will be concluded as the guarantees already given by GESAI are returned by ANEEL.
