("Empire Capital"), with respect to the 3,151,340 shares, Empire Capital Partners, Ltd. a Cayman Islands exempted company ("Offshore") as to 2,849,568 shares, Empire Capital Partners II, Ltd., a Cayman Islands exempted company ("Offshore II") as to 527,981 shares, Charter Oak Partners, LP a Delaware Limited Partnership ("Charter Oak") as to 952,500 shares and Charter Oak Partners II ("Charter Oak II") and collectively with Empire Capital, Offshore, Offshore II, and Charter Oak, "the Empire Funds") as to 113,870 shares of Common Stock directly owned by it.
