EGLLC owns 90,000,000 shares of the common stock of the Issuer directly. Black Diamond Holdings LLC ("BDH") is the owner of ninety-nine percent (99%) of the membership interests of EGLLC. Mr. Imeson owns indirectly, through certain investment funds that comprise BDH, 3.53% of the membership interests of EGLLC. As such, Mr. Imeson is deemed to beneficially own indirectly, 3,177,000

(1) shares (3.21%) of the common stock of the Issuer owned by EGLLC. Mr. Imeson is a manager of Black Diamond Financial Group LLC, which is the manager of BDH. As such, Mr. Imeson has sole voting and investment power with respect to all of the 90,000,000 shares of the the common stock of the Issuer owned by EGLLC and may be deemed to beneficially own all of that stock owned by EGLLC. Mr. Imeson disclaims beneficial ownership of 86,823,000 shares (96.79%) of this stock.
