- (1) Pursuant to Mr. Peterson's 4/17/17 employment agreement, on 4/17/17 he was granted 192,307 restricted shares of Revlon, Inc. Class A Common Stock, par value \$0.01 per share, under the Fourth Amended and Restated Revlon, Inc. Stock Plan. Pursuant to his employment agreement, one-fifth of the restricted shares will vest in equal amounts on each of 4/17/18, 4/17/19, 4/17/20, 4/17/21 and 4/17/22, so long as Mr. Peterson remains employed with the Company on each applicable vesting date, subject to certain earlier vesting provisions.
