On February 8, 2006, Pediatrix Medical Group, Inc. (the "Company") issued a press release announcing its results of operations for the three and twelve months ended December 31, 2005 (the "Release"). In the Release, the Company announced that it had reached an agreement in principle as to a settlement amount of \$25.1 million relating to the previously disclosed federal and state Medicaid and TRICARE investigation. The amount of the settlement is subject to necessary governmental approvals. The settlement is also subject to the negotiation and approval of a definitive settlement agreement by state and federal authorities. The last five sentences of the first paragraph, the first sentence of the fourth paragraph and the thirteenth and fourteenth paragraphs of the Release describing the financial settlement and the last textual paragraph of the Release containing cautionary statements regarding forward looking information is hereby incorporated by reference in this Current Report.
