(1) Represents shares withheld pursuant to the terms of a shareholder-approved stock plan for the payment of federal and state withholding taxes due upon the January 2, 2008 vesting of 13,125 of the 70,000 shares of restricted stock Mr. Mammone was granted on November 16, 2006. These 5,250 shares are not sold on the open market and become Revlon, Inc. treasury shares.

(2) Of the 103,905 shares reflected as beneficially owned, (a) 24,792 are unvested restricted shares that the reporting person was granted on November 16, 2006, 13,125 of which vest on July 1, 2008, 5,833 of which vest on November 16, 2008 and 5,834 of which vest on November 16, 2009, and (b) 50,000 are unvested restricted shares that the reporting person was granted on December 10, 2007, 16,666 of which vest on January 2, 2009, 16,667 of which vest on January 2, 2010, and 16,667 of which vest on January 2, 2011.
