Each of the 2011 and 2012 payments will be half in cash, half in shares of the Company's Class A Common Stock.
- (7) Two-thirds of the reported units (plus related dividend units) will be settled and payable on or about March 1, 2011, and the remaining reported units (plus related dividend units) will be settled and payable on our about March 1, 2012.
