- (1) Consists of the following shares purchased by the following entities: (a) 88,641 shares purchased by ABS Capital Partners VI, LP ("ABS VI"); (b) 1,569 shares purchased by ABS Capital Partners VI-A, LP ("ABS VI-A"); and (c) 9,790 shares purchased by ABS Capital Partners VI Offshore, LP ("ABS VI Offshore," and together with ABS VI and ABS VI-A, the "ABS Entities"). ABS Partners VI, LLC is the general partner of the ABS Entities and has voting and dispositive powers over these shares.
- (2) The price of \$28.3221 per share represents a weighted average of purchase prices ranging from \$28.20 to \$28.41 per share. The reporting person undertakes to provide upon request by the Commission staff, the issuer, or a security holder of the issuer, full information regarding the number of shares purchased at each separate price.
- (3) Mr. Weglicki is a member of ABS Partners VI, LLC, the general partner of the ABS Entities. ABS Partners VI, LLC exercises voting and dispositive power over the shares held by the ABS Entities. Mr. Weglicki disclaims beneficial ownership of the shares held by the ABS Entities except to the extent of his pecuniary interest therein.
