(1) On 06/03/2011, the Reporting Person was awarded a number of performance-based restricted stock units (RSUs), within a preset range, with the actual number contingent upon the achievement of a certain performance criterion. If the performance criterion is achieved, fifty percent (50%) of the RSUs granted vest on the next business day following the third and fourth anniversaries of the date of grant, subject to applicable taxes upon delivery.

(2) Disposition of shares exempt under Rule 16b-3 as payment of tax liability to Company incident to vesting of restricted stock share award.

(3) Price reflects weighted average sales price; actual sales prices ranged from \$11.971 to \$11.980. The Reporting Person undertakes to provide, upon request by the Commission staff, the Issuer, or a security holder of the Issuer, full information regarding the number of shares purchased or sold at each separate price.

(4) Includes the following: (1) 18,750 unvested Restricted Stock Units, which will vest on May 17, 2016; (2) 37,500 unvested Restricted Stock Units, which will vest in two equal annual installments beginning on May 21, 2016; and (3) 50,057 unvested Restricted Stock Units, which will vest in four equal annual installments beginning on June 26, 2015.
