**Item 2.03 Creation of a Direct Financial Obligation or an Obligation under an Off-Balance Sheet Arrangement of a Registrant.**

On September 30, 2005, the registrant and certain of its subsidiaries entered into a five-year unsecured credit facility (the Credit Facility ) with Citicorp USA, Inc., as administrative agent, and certain banks named therein, as lenders thereunder, in an aggregate amount of up to \$1,500,000,000. The Credit Facility replaces the registrant's existing five-year credit facility. The registrant intends to use any borrowings under the Credit Facility for the general corporate purposes of the registrant and its subsidiaries (including in connection with the commercial paper program of the registrant and certain of its subsidiaries). The Credit Facility is subject to early termination by the registrant upon satisfaction of customary notice and other requirements. Borrowings under the Credit Facility are subject to acceleration upon the occurrence of customary events of default.
