## Kayne Anderson MLP Investment Company Prices Public Follow-On Offering of Common Stock

Houston, TX July 10, 2013 Kayne Anderson MLP Investment Company (the Company ) (NYSE: KYN) announced the pricing of a public offering of common stock. The Company agreed to sell a total of 6,200,000 shares at a price of \$36.00 per share (exclusive of 930,000 additional shares that the underwriters may purchase pursuant to a 45-day option to cover over-allotments). Net proceeds from the offering of \$214.3 million will be used to make additional portfolio investments that are consistent with the Company's investment objective and policies and for general corporate purposes. The offering is scheduled to close on July 15, 2013.
