On January 13, 2017, pursuant to the Agreement and Plan of Merger, dated as of November 10, 2016 (the Merger Agreement), between SBA Communications Corporation, a Florida corporation (the Predecessor Registrant), and SBA Communications REIT Corporation, a Florida corporation (the Registrant), the Predecessor Registrant merged with and into the Registrant (the Merger), with the Registrant surviving the Merger. At the effective time of the Merger (the Effective Time), the Registrant changed its name from SBA Communications REIT Corporation to SBA Communications Corporation. At the Effective Time and pursuant to the Merger Agreement, all outstanding shares of the Class A common stock, par value \$0.01 per share, of the Predecessor Registrant (the Predecessor Common Stock) automatically converted into the right to receive an equal number of shares of Class A common stock, par value \$0.01 per share, of the Registrant Common Stock). Pursuant to this Form 15, the Registrant, as the successor entity to the Predecessor Registrant, is terminating the registration of the Predecessor Common Stock. The Registrant Common Stock, including the Registrant s duties to file reports with respect thereto, is not affected by this Form 15.
