(d) Election of Eric Paul Pâques as Director

On February 8, 2017, the Board of Directors of the Company (the Board) appointed Eric Paul Pâques as a Class I director, effective immediately, to hold office until the Company s 2018 Annual Meeting of Stockholders or until his successor is duly elected and qualified.

The Nominating and Corporate Governance Committee of the Board conducted the search for director candidates. It has not formulated any specific minimum qualifications for director candidates, but has determined certain desirable characteristics including independence, sound judgment, business specialization, technical skills, diversity and other desired qualities. After reviewing several director candidates, the Nominating and Corporate Governance Committee recommended Mr. Pâques for appointment to the Board.

There are no related party transactions between Mr. Pâques and the Company, and the Company believes that Mr. Pâques satisfies the independence requirements of Rule 5605(a)(2) of the NASDAQ Stock Market listing rules and Rule 10A-3 under the Securities Exchange Act.

Upon his appointment to the Board, the Company granted Mr. Pâques restricted stock units for 543 shares of the Company s Class A common stock vesting in full on the one-year anniversary of the date of grant. In addition, as a member of the Board, Mr. Pâques will receive the same compensation paid by the Company to its other non-employee directors under the Company s existing director compensation program.
