- (1) The reported transaction involves an award of restricted stock units under the M&T Bank Corporation 2009 Equity Incentive Compensation Plan. Each restricted stock unit represents a contingent right to receive one share of M&T Bank Corporation common stock upon vesting.
- The restricted stock unit award includes a total of 4,746 shares. 1,423 shares of the restricted stock unit award will vest on January 29, 2012; an additional 1,424 shares will vest on January 29, 2013; and the remaining 1,899 shares will vest on January 29, 2014. The restricted stock unit award may also be subject to restrictions on transfer upon settlement. For more information, please see the Current Report on Form 8-K filed by M&T Bank Corporation on January 25, 2010.
- (2) The restricted stock units were granted under an incentive compensation plan maintained by M&T Bank Corporation, and therefore the reporting person paid no price for the shares.
- (3) The reporting person's direct holdings reflect the correction of a gift transaction that was reported on a prior Form 4 filing as part of a series of gifts made by the reporting person on November 30, 2009 that understated the total number of shares gifted by one share.
- (4) The information presented is as of December 31, 2009.
- The indicated shares are held by Grantor Retained Annuity Trusts No's. 5 and 6, respectively, under indentures dated July 23, 1993 (individually, a "GRAT" and collectively, the "GRATs"). The reporting person is a trustee of each GRAT and holds sole voting and dispositive power over the shares held by the GRATs.
- (5) The indicated shares are held by a limited liability company of which the reporting person is the sole member.
- The indicated shares are held by the Roche Foundation, a Delaware not-for-profit, non-stock corporation in which the reporting person has no pecuniary interest. The reporting person is the sole director and president of the Roche Foundation and holds sole voting and dispositive power over the shares held by it.
- (6) The reported transaction involves a transfer of securities by gift for which no payment of consideration was received by the reporting person.
