A total of 16,798,160 shares of common stock, representing 78.31% of the shares of common stock outstanding and eligible to vote and constituting a quorum, were represented in person or by valid proxies at the Annual General Meeting. The final results for each of the matters submitted to a vote of stockholders at the Annual General Meeting as set forth in the Proxy Statement are as follows:

Proposal 1. All the three nominees for directors in Class II were elected to serve until the 2020 Annual General Meeting of Stockholders and until their respective successors have been duly elected and qualified, or until such director's earlier resignation, removal or death.
