- (1) On November 17, 2015, BofI Holding, Inc. effected a four-for-one stock split. The amount and price of shares reported throughout this Form 4 have been adjusted to reflect the stock split. The Reporting Person acquired a pre-split-adjusted equivalent of 500 shares at a pre-split-adjusted equivalent weighted average price of \$87.17.
- (2) This transaction was executed in multiple trades, at prices ranging from \$21.70 to \$21.88 (pre-split-adjusted equivalent prices of \$86.80 to \$87.50). The price reported above reflects the weighted average purchase price. The reporting person hereby undertakes to provide upon request by the SEC staff, the issuer or a security holder of the issuer, full information regarding the number of shares purchased and the prices at which each individual trade was effected.
- (3) The amount of shares beneficially owned above are as of September 1, 2016. As of the transaction date of November 13, 2015 the number of shares beneficially owned following the Reported Transaction were 101,744 (25,436 on a pre-split-adjusted basis).
