On October 14, 2008, The Andersons, Inc. entered into the Fifth Amendment to Amended and Restated Loan Agreement ("Agreement") with several banks including U.S. Bank National Association, acting as Agent and as one of its Lenders. The Amendment extended the Line of Credit B through April 11, 2009. The amount available under the extended Line of Credit B is \$161.0 million.
