This Amendment No. 2 to Schedule 13D amends and supplements the Schedule 13D filed by LKCM Private Discipline Master Fund SPC, LKCM Private Discipline Management, L.P., LKCM Alternative Management, LLC, Luther King Capital Management Corporation, J. Luther King, Jr. and J. Bryan King (collectively, the Reporting Persons) with respect to the Class A Common Stock, par value \$0.01 per share (Common Stock), of Emmis Communications Corporation (the Issuer). Except as set forth below, all previous Items remained unchanged. Capitalized terms used herein but not defined herein have the meanings given to them in the Schedule 13D, as amended, filed with the Securities and Exchange Commission.

Item 3. Source and Amount of Funds or Other Consideration

Item 3 is hereby supplemented as follows:

From December 10, 2008 through December 30, 2008, Master Fund acquired 606,347 shares of Common Stock in open market transactions for an aggregate purchase price of approximately \$238,000 using working capital.

Item 5. Interest in Securities of the Issuer

Item 5 is hereby amended and restated as follows:

(a) As of December 30, 2008, the Reporting Persons may be deemed to beneficially own 2,950,000 shares of Common Stock (which represents approximately 9.4% of the outstanding Common Stock, based upon information contained in the Issuer s Quarterly Report on Form 10-Q for the quarterly period ended August 31, 2008).
