At the 2016 Annual Meeting of Stockholders of Realogy Holdings Corp. ("Realogy Holdings" or the "Company") held on May 4, 2016 (the "2016 Annual Meeting"), the Company's stockholders, upon the recommendation of the Company's Board of Directors, approved the Amended and Restated 2012 Long-Term Incentive Plan, including an amendment to increase the aggregate number of shares authorized for issuance thereunder by 9,800,000 shares. A summary of the Amended and Restated 2012 Long-Term Incentive Plan was included in the Company's definitive proxy statement filed with the Securities and Exchange Commission on March 16, 2016 (the "2016 Proxy Statement") under the section captioned "Proposal to Approve the Amended and Restated 2012 Long-Term Incentive Plan" and is incorporated herein by reference.
