This Amendment No. 3 (this "Amendment") amends, as set forth below, the statement on Schedule 13D, dated May 20, 2014 and filed with the SEC on May 28, 2014 (the "Original Schedule 13D"), as amended by Amendment No. 1 dated May 20, 2014 and filed with the SEC on May 29, 2014 ("Amendment No. 1"), as further amended by Amendment No. 2 dated July 1, 2016 and filed with the SEC on July 6, 2016 ("Amendment No. 2"), for Bank of America Corporation ("BAC") and Banc of America Preferred Funding Corporation ("BAPFC") (collectively, the "Reporting Persons") with respect to the variable rate munifund term preferred shares ("VMTP Shares") of Nuveen Maryland Quality Municipal Income Fund (the "Issuer") formerly known as Nuveen Maryland Premium Income Municipal Fund.
