- (1) The Issuer effected a 1-for-5 reverse stock split of its common stock on March 26, 2019. All share and per share exercise price amounts shown in this Form 4 have been adjusted to reflect the reverse stock split.

These options were granted on 1/10/2019. These options vest, subject to continued employment, as follows: 35% of the options vest over
- (2) time, with 25% vested on the grant date and 25% vesting on the first, second and third anniversaries of the grant date; and 65% of the options vest upon the achievement of certain milestones.
- (3) The option vests based on certain performance milestones. The option will be forfeited if such milestones are not met by certain dates.
- (4) These options vested upon the achievement of certain milestones, subject to continued employment.
- (5) One third of these options vested upon the achievement of a certain milestone and one third vested on each of December 31, 2015 and July 28, 2015.
- (6) 15,000 of these options vest monthly over four years, beginning on March 9, 2016, 20,000 vest upon the achievement of a certain milestone, subject to continued employment, and the rest vested upon the achievement of certain milestones.
