- The vesting of these performance-based restricted stock units ("PRSU") is dependent upon the achievement by Stericycle, Inc. of certain financial performance criteria. Subject to continued employment through the applicable vesting date and to accelerated vesting in certain circumstances, one-third (1/3) of the target number of PRSUs is scheduled to vest annually on each anniversary of the grant date following each of the 2018, 2019, 2020 and 2021 annual performance periods. Each year, the number of units that actually vest will be 0% to 100% of the scheduled amount, depending on the extent to which Stericycle, Inc. meets certain financial performance goals.
- (1) No shares were sold. 172 shares were withheld by the Issuer to satisfy the minimum statutory tax withholding requirements on vesting of PSUs.
 - (2) This award was granted on March 1, 2018 for 3,621 shares. 519 shares vested on March 1, 2019. All unvested PSUs are subject to continued employment through the applicable vesting date.
