Each of the Reporting Persons beneficially owns 1,358,482 shares of Common Stock, which represents 8.7% of the Issuer's outstanding Common Stock, based on the 15,474,311 shares outstanding as of December 31, 2005, plus the shares the Reporting Persons' have the right to acquire. This total includes (a) 1,117,741 shares of Common Stock jointly held by the Reporting Persons, (b) 200,000 shares of Common Stock issuable upon the exercise of outstanding options held by Mr. Stonecipher, (c) 20,000 shares of Common Stock issuable upon the exercise of outstanding options held by Mrs. Stonecipher, and (d) 20,741 shares held by Mr. Stonecipher through the Issuer's Employee Stock Ownership and Thrift Plan and Trust. Neither of the Reporting Persons has the sole power to vote or to direct the vote of any shares of Common Stock, but each of the Reporting Persons has the shared power to vote or to direct the vote of 1,358,482 shares of Common Stock. Neither of the Reporting Persons has the sole power to dispose or to direct the disposition of any shares of Common Stock, but each of the Reporting Persons has the shared power to dispose or to direct the disposition of 1,358,482 shares of Common Stock.
