Restricted Stock Units are payable in common stock on a one-for-one basis upon a director's death, disability, retirement, or a change in control, as defined in the PG&E Corporation 2006 LTIP. This total includes 752.97 units of phantom stock granted under the PG&E Corporation Non-Employee Director Stock Incentive Plan (SIP), and reflects the acquisition of 6.46 units of phantom stock on April 15, 2005, 5.96 units of phantom stock on July 15, 2005, and 6.07 units of phantom stock on October 17, 2005, pursuant to a dividend reinvestment feature of the SIP. This total also includes 800.64 Restricted Stock Units granted under the PG&E Corporation 2006 LTIP. The phantom stock units and the Restricted Stock Units are automatically payable in stock only.
