On September 26, 2014, the reporting person was granted an option to purchase 81,750 shares of common stock. The option vests in five (1) equal annual installments based on Wingstop's satisfaction of certain performance criteria for each of the fiscal years 2015, 2016, 2017, 2018 and 2019. The performance criteria for 2015 were met, resulting in vesting of the option as to 16,350 shares.
