As of the close of business on December 31, 2016 (i) BVF beneficially owned 1,352,312 shares of Common Stock, (ii) BVF2 beneficially owned 883,470 shares of Common Stock, and (iii) Trading Fund OS beneficially owned 262,664 shares of Common Stock.

Partners OS as the general partner of Trading Fund OS may be deemed to beneficially own the 262,664 shares of Common Stock beneficially owned by Trading Fund OS.

The following percentages are based on 17,865,347 shares of Common Stock outstanding, as disclosed in the Issuer’s Quarterly Report filed on Form 10-Q with the Securities and Exchange Commission on November 3, 2016.

As of the close of business on December 31, 2016 (i) BVF beneficially owned approximately 7.6% of the outstanding shares of Common Stock, (ii) BVF2 beneficially owned approximately 5.0% of the outstanding shares of Common Stock, (iii) Trading Fund OS beneficially owned approximately 1.5% of the outstanding shares of Common Stock (iv) Partners OS may be deemed to beneficially own approximately 1.5% of the outstanding shares of Common Stock, and (v) each of Partners, BVF Inc. and Mr. Lampert may be deemed to beneficially own approximately 17.0% of the outstanding shares of Common Stock (approximately 3.1% of which is held in the Partners Managed Accounts).
