ATTACHMENT A

As of April 24, 2003, Select and Select Offshore are the beneficial owners of 740,900 shares of Common Stock of Atwood Oceanics, Inc. ("Common Stock"), for a total beneficial ownership of 5.35% of the outstanding shares of Common Stock.
