Capital Group International, Inc. ("CGII") is the parent holding company of a group of investment management companies that hold investment power and, in some cases, voting power over certain of the securities reported in this Schedule 13G. The investment management companies, which include a "bank" as defined in Section 3(a)(6) of the Securities Exchange Act of 1934 (the "Act") and several investment advisers registered under Section 203 of the Investment Advisers Act of 1940, provide investment advisory and management services for their respective clients which include registered investment companies and institutional accounts. CGII does not have investment power or voting power over the securities managed for its clients. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 3,160,235 shares or 16.7% of the 18,961,235 shares of Class A Common Stock believed to be outstanding.

In addition, CGII owns 2,861,235 Class B shares for its own account. These shares are convertible into Class A shares on a one-to-one basis, and are treated as having been converted into 2,861,235 Class A shares for the purpose of this filing, and are included in the totals above.
