The Bank of New York Mellon Corporation, One Wall Street, New York, NY 10286, U.S.A., disclosed on February 23, 2015, that its total holding in Syngenta now amounts to 3,178,531 shares (3.42% of the total share capital), split into 3,166,062 registered shares plus purchase rights on ADRs (ISIN US87160A1007, 1 ADR=0.2 share) corresponding to 12,469 shares.
