**(e) Compensatory Arrangements of Certain Officers**

On June 20, 2011, the Compensation Committee of the Board of Directors of Northrop Grumman Corporation (the Company ) approved a lump sum payment of \$750,000 to James F. Palmer, Corporate Vice President and Chief Financial Officer, in lieu of relocation benefits to which he is otherwise entitled. The payment is to be made upon Mr. Palmer's relocation to the Company's new headquarters in Falls Church, Virginia. In exchange for this payment, Mr. Palmer will forfeit all benefits he would have been entitled to receive under the Company's relocation policy. The terms are set forth in their entirety in a letter dated June 23, 2011, signed by Mr. Wes Bush, Chief Executive Officer and President of the Company, and accepted by Mr. Palmer. A copy of the letter is attached as Exhibit 10.1 to this Report.
