(3) Includes 5,541.35 Special Incentive Stock Ownership Premiums (SISOPs) (phantom stock) awarded pursuant to the PG&E Corporation Executive Stock Ownership Program, and reflects the acquisition of 45.98 SISOPs on April 17, 2006, 45.22 SISOPs on July 17, 2006, and 42.90 SISOPs on October 16, 2006, pursuant to a dividend award feature of the PG&E Corporation Executive Stock Ownership Program. SISOPs vest three years after the date of grant subject to accelerated vesting upon certain events. Unvested SISOPs are subject to forfeiture if certain stock ownership targets are not met. Vested SISOPs are automatically payable in an equal number of shares following termination of employment.

(4) Represents the approximate number of shares of PG&E Corporation common stock held for the reporting person in the PG&E Corporation Retirement Savings Plan (RSP). That fund holds units consisting of PG&E Corporation common stock and a small short-term investments component. The number of shares is computed by dividing the value of the units by the daily closing price. Dividends are automatically invested in additional units at the election of the participant. These holdings have been trued up to conform to the RSP balance at January 3, 2007, and reflect the acquisition of approximately 18.89 shares on April 17, 2006, 19.34 shares on July 17, 2006, and 18.37 shares on October 16, 2006, due to dividend reinvestment.

(5) The option vested in three equal installments on January 2, 1999, January 2, 2000, and January 2, 2001.
