- (1) Restricted stock units convert into common stock on a one-for-one basis. Accordingly, there was no purchase price paid by the reporting person.
- (2) On September 19, 2015, 3,045 shares of United Natural Foods, Inc. (the "Company") restricted stock units vested. The Company retained 1,460 shares on that date to satisfy certain tax withholding obligations in connection with the vesting.
