( Liberty Satellite ). As a result of its control of Liberty Satellite, the Reporting Person may be deemed to be the beneficial owner of 19,404,240 shares of Common Stock held by Ascent Entertainment Group, Inc., a wholly owned subsidiary of Liberty Satellite, 2,044,444 shares of Common Stock held directly by Liberty Satellite, as well as the 1,329,368 shares of Common Stock held by Liberty Satellite as a result of the acquisition reported hereby. The Reporting Person also beneficially owns 125 shares of Common Stock through one of its wholly owned subsidiaries.
