Disposed of pursuant to the Agreement and Plan of Merger, dated as of July 6, 2006 (the "Merger Agreement"), by and among

(1) Radiologix, Inc. ("Radiologix") and Primedex Health Systems, Inc. ("Primedex") in exchange for a one for one exchange of Radiologix Common Stock for Primedex Common Stock and a cash payment of \$7,160, or \$1.79 per share.

(2) This option became exercisable as to 10,000 shares upon optionee's completion of one year of service as a director on September 18, 2002, and thereafter as to 833 shares per month for 24 months.

(3) This option becomes exercisable as to 1/12th of the option shares per month for 12 months.
