- (1) On August 16, 2011, the issuer canceled, pursuant to the issuer's option exchange program, an option granted to the reporting person on November 19, 2003 (such canceled option provided for vesting in four equal installments beginning on November 19, 2004). In exchange for the option, the reporting person received 2,891 restricted stock units, all of which are scheduled to vest on August 16, 2012. Each unit converts into a share of common stock on a one-for-one basis.
