Qualified holding and long position Morgan Stanley

Portugal Telecom, SGPS S.A. (PT) hereby informs that Morgan Stanley now holds less than 2% of the share capital of PT.

This change resulted from the disposal on 31 October 2013, of 2,425,695 PT ordinary shares by Morgan Stanley & Co. International plc. As a result, Morgan Stanley now holds a holding corresponding to a total of 15,109,851 ordinary shares representing 1.69% of PT's share capital and corresponding voting rights. Additionally, PT was informed that this holding is as follows:

Holdings in PT ordinary shares:

- Morgan Stanley & Co. International plc: 8,549,956 ordinary shares representing 0.95% of the share capital and voting rights in PT ;
- Morgan Stanley & Co. LLC: 4,565,693 ordinary shares representing 0.51% of the share capital and voting rights in PT;
- Morgan Stanley Smith Barney LLC: 163,696 ordinary shares representing 0.02% of the share capital and voting rights in PT;
- MS Equity Financing Services (Luxembourg) S.a.r.l.: 1,499,417 ordinary shares representing 0.17% of the share capital and voting rights in PT.

Holdings in financial instruments:

- Morgan Stanley & Co. International plc: 331,089 ordinary shares via bond exchangeable into shares already in issue, representing 0.04% of the share capital and voting rights in PT.
