Item 7.01 Regulation FD Disclosure.

On March 27, 2015, Dynegy Inc. (Dynegy) issued a press release announcing that the Federal Energy Regulatory Commission issued orders authorizing Dynegy s wholly-owned subsidiary, Dynegy Resource I, LLC, to acquire the ownership interests in certain generation facilities located in Ohio, Illinois and Pennsylvania and retail energy business from Duke Energy; authorizing Dynegy s wholly-owned subsidiary, Dynegy Resource II, LLC, to acquire the ownership interests in EquiPower Resources Corp. from certain affiliates of Energy Capital Partners; and authorizing Dynegy s wholly-owned subsidiary, Dynegy Resource III, LLC, to acquire the ownership interests in Brayton Point Holdings, LLC from certain affiliates of Energy Capital Partners. A copy of the press release is being furnished pursuant to Regulation FD as Exhibit 99.1 to this Current Report on Form 8-K.
