**Explanatory Note**

This Amendment No. 1 to Current Report on Form 8-K (this Form 8-K/A ) amends the Current Report on Form 8-K of PDC Energy, Inc. (the Company ) filed with the Securities and Exchange Commission on August 31, 2017 (the Original Form 8-K ), which reported the appointment of Mark E. Ellis to serve as a Class III director of the Company. Pursuant to Instruction 2 to Item 5.02 of Form 8-K, this Form 8-K/A is being filed solely to provide information called for in Item 5.02(d)(3) of Form 8-K that had not been determined at the time of filing of the Original Form 8-K.

**Item 5.02. Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.**

On September 30, 2017, the Board of Directors of the Company appointed Mr. Ellis to its Compensation Committee and its recently formed Midstream Committee. In addition to Mr. Ellis's participation in the Company's standard non-employee director compensation arrangements, which were disclosed in the Original Form 8-K, Mr. Ellis will receive compensation identical to other members of such committees, consisting of (i) an annual cash retainer equal to \$12,000 payable in quarterly installments for his service on the Compensation Committee and (ii) an annual cash retainer equal to \$10,000 payable in quarterly installments for his service on the Midstream Committee.
