These holdings have been trued up to conform to the RSP balance as of January 2, 2009, and reflect the acquisition of approximately 1.08 shares on April 15, 2008, 1.20 shares on July 15, 2008, and 1.54 shares on October 15, 2008 due to dividend reinvestment.
