- (3) These transactions reflect the extension of the expiration date of phantom stock from 3/1/2010 to "retirement" under arrangements approved by the Compensation Committee and reflect the movement of stock from the Phantom 3/07D account to the "retirement" account.

- (4) RSUP6 award listed in Table II has been reported at 75% of the original grant amount, as that represents the minimum amount guaranteed to be paid out upon vesting. Because of the performance targets achieved, the award was paid out on March 1, 2010, at a performance-rate of 125%. The shares coded "A" represent that portion attributable to this performance adjustment. The shares coded "F" were withheld to cover income tax obligations associated with the payout.
