- Shares of common stock acquired upon the vesting of performance stock units awarded on March 7, 2008. The Reporting Person received

 - (6) The Time Warner Savings Plan, a qualified employee benefit plan (the "Savings Plan"). Includes shares of common stock acquired through the reinvestment of dividends paid on the common stock held by the Savings Plan.
 - (7) These restricted stock units vest in two equal installments on the third and fourth anniversaries of their dates of grant, January 2, 2008, March 7, 2008, February 20, 2009, February 8, 2010 and February 7, 2011.
