These holdings have been trued up to conform to the RSP balance as of 3/3/14, and reflect the acquisition of approximately 15.51 shares on 4/15/13, 16.87 shares on 7/15/13, 19.55 shares on 10/15/13, and 19.52 shares on 1/15/14 due to dividend reinvestment.
