- (1) The Board authorized the cash payout of the 2013 - 2015 cycle of performance shares, no earlier than February 18, 2016, based on the high and low prices of FirstEnergy's stock for the month of December 2015. Based on performance, the amount of the cash payout was decreased to 25% of the original award amount.
- (2) Balance includes shares acquired through dividend reinvestment.

the granting of the award. Due to performance goals achieved, the number of RSUs under the award has been increased to 150% of the original target amount. Restricted stock units, coded "A", represent that portion of the award that was not previously reported. Amounts also reflect dividend reinvestment. RSUP18 will vest on March 1, 2016.
