- (5) the granting of the award. Due to performance goals achieved, the number of RSUs under the award has been increased to 150% of the original target amount. Restricted stock units, coded "A", represent that portion of the award that was not previously reported. Amounts also reflect dividend reinvestment. RSUP18 will vest on March 1, 2016.
