- (1) 10,000 units were awarded pursuant to the Issuer's Long-Term Incentive Plan as restricted units and are scheduled to vest in four equal annual installments beginning on June 26, 2008.
- (2) The subordinated units shall convert into common units on a one-for-one basis after December 31, 2006, upon satisfaction of the conditions for conversion set forth in the Issuer's First Amended and Restated Agreement of Limited Partnership, as amended. The conditions are based on the amount of quarterly distributions by the Issuer with respect to its common and subordinated units. As of date, the conditions have not been satisfied. The subordinated units have no expiration date.
