- (1) On January 3, 2012, the Issuer entered into an agreement with Thomas D. Myers (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 11,000 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").
- (2) This figure includes 91,000 restricted shares of Class A Common Stock issued pursuant to the Restricted Stock Award Plan. On January 2, 2012, restrictions applicable to previously reported grants of 19,700 shares of Class A Common Stock lapsed, resulting in the reporting person becoming fully vested in such shares. This resulted in no change in the number of shares beneficially owned by the Reporting Person.
- (3) Mr. Myers is the direct beneficial owner of 128,950 shares of Class A Common Stock, including the 91,000 restricted shares referenced in footnote 2. In addition, he is the indirect beneficial owner of 1,041 shares of Class A Common Stock owned by the Trust established under the Urstadt Biddle Properties Inc. Excess Benefit and Deferred Compensation Plan of 2005 for the benefit of Mr. Myers.
